ARTICLES OF ORGANIZATION

MacFawn's Distributing, LLC

A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)

1. Name. The name of the limited liability company is MacFawn's Distributing, LLC.

2. Purpose. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

3. Address/Mailing Address of Principal Office. The address of the principal office of the limited liability company is 4810 Shady Glen Drive - Lakeland, Florida 33810.

4. Term. Term of this LLC shall be perpetual.

5. Members at Time of Formation. There will be at least one member at the time the limited liability company is formed.

6. Period of Duration. The period of duration shall be perpetual.


