

ARTICLES OF ORGANIZATION
OF
LAKE REGION MULTIPLE LISTING NETWORK, LLC

The undersigned, as authorized representative of Trevor Waters Realty, Inc., a member of the below-identified limited liability company, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I -- NAME
