ARTICLES OF ORGANIZATION OF HANSEN & WILLIAMS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be HANSEN & WILLIAMS, LLC, ("Company").

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE

ARTICLE VI - ADMISSION OF NEW MEMBERS

Except as set forth in the Regulations, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company only as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his, her or its interest approve of the proposed transfer by written consent.

ARTICLE VII -MEMBER'S RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, including the occurrence of an event whereby any of the stock of SPIDER ONLINE SOLUTIONS, INC. is owned by a person or entity other than CARL A. HANSEN, unless the business of the Company is continued by a majority vote of the remaining members.




