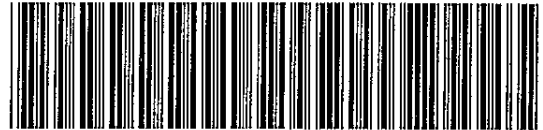





ARTICLES OF DISSOLUTION
FOR
FULTON CAPITAL, LLC
A FLORIDA LIMITED LIABILITY COMPANY

1. The name of the Florida limited liability company is **FULTON CAPITAL, LLC**.
2. The effective date of the limited liability company's dissolution is **JANUARY 31, 2003**.
3. Pursuant to Section 11.1 (a) of **FULTON CAPITAL, LLC's** Operating Agreement, the Company's sole Member has elected to dissolve and conclude the affairs of **FULTON CAPITAL, LLC** effective January 31, 2003.
