# ARTICLES OF ORGANIZATION OF FAR NIENTE, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statues, does hereby adopt the following Articles of Organization:

#### **ARTICLE I. NAME**

The name of the limited liability company is FAR NIENTE, LLC (the "Company").
