## ARTICLES OF ORGANIZATION MDC, LLC PAGE TWO

ARTICLE 5 The purpose for which the Limited Liability Company is organized is:

To engage in the transaction of any or all lawful business for which Limited Liability Companies may be organized under the laws of the State of Florida.

**ARTICLE 6** The members of the Limited Liability Company Shall have the right to admit additional members to the Limited Liability Company upon the unanimous consent of all members of the Limited Liability Company.
