ARTICLES OF ORGANIZATION OF VILLAGE WALK SOUTH OF VERO BEACH, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be VILLAGE WALK SOUTH OF VERO BEACH, LLC, ("company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the regulations.

ARTICLE IV - REGISTERED AGENT AND OFFICE

ARTICLE V - ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company

ARTICLE VI - MEMBERS' RIGHT TO CONTINUE BUSINESS

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
