AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF MITTY EVENTS, LLC

(a Florida limited liability company)

The undersigned, as managing member of MITTY EVENTS, LLC, a Florida limited liability company (the "Company"), hereby amends and restates the Articles of Organization of the Company and certifies that:
