ARTICLES OF ORGANIZATION
OF

(a Florida limited liability company)

The undersigned, as managing member of MITTY EVENTS, LLC, a Florida limited liability company (the "Company"), hereby amends and restates the Articles of Organization of the Company and certifies that:

1. The name of the Company is MITTY EVENTS, LLC.

3. These Amended and Restated Articles of Organization restate and amend the provisions of the Company's Articles of Organization, in their entirety, as follows:
