**ARTICLES OF ORGANIZATION
OF
CONTRACT HARDWARE SUPPLY GROUP, L.L.C.**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. **Name.** The name of this limited liability company is CONTRACT HARDWARE SUPPLY GROUP, L.L.C. ("Company").

2. **Duration.** The Company shall exist from the date of filing these Articles with the Department of State until 25 years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

3. **Mailing Address and Street Address.** The Company's mailing address is 3501 S. Orange Blossom Trail, Orlando, Florida 32839. The Company's street address is 3501 S. Orange Blossom Trail, Orlando, Florida 32839.

4. **Registered Agent and Office.** The name of the initial registered agent of the Company is Bobbie C. Hirschy. The street address of the initial registered agent of the Company is 3501 S. Orange Blossom Trail, Orlando, Florida 32839.

5. **Additional members.** Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

6. **Termination of Membership.** If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

7. **Management of the Company.** The Company shall initially be managed by the following one person who shall serve as manager until the first annual meeting of the members or until their successors are elected and qualify:


Thereafter, the Company shall be managed by the managers who shall be elected annually as provided in the regulations.


9. **Date of Existence of the Company.** The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.


