The undersigned hereby executes and acknowledges these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this company is **EDWARD LOUIS FLOM FAMILY L.L.C.**

**ARTICLE II
PERIOD OF DURATION**

This company shall commence as of the date these Articles of Organization are filed with the Department of State of the State of Florida and shall exist perpetually thereafter, unless this company is dissolved pursuant to the terms of the operating agreement of this company or by operation of law.

**ARTICLE III
PRINCIPAL OFFICE**

EQUITY STRUCTURE**

The ownership of this company shall be represented by Units having the preferences, rights and obligations specified in the operating agreement of this company. This company shall have Class A Units and Class B Units. Each Class A Unit held by a member of this company shall entitle

such member to cast one vote. A Class B Unit shall not entitle a member to any vote. Except for voting rights there shall be no difference between the Class A Units and the Class B Units.

ARTICLE VII OPERATING AGREEMENT

(a) The power to adopt the operating agreement of this company shall be vested in the members of this company. Once adopted, the operating agreement of this company may only be altered, amended or repealed in the manner specified in such agreement.

(b) The operating agreement of this company shall be for the government of this company and may contain any provisions or requirements for the management or conduct of the affairs and business of this company, provided the same are not inconsistent with the provisions of these Articles of Organization, or contrary to the laws of the State of Florida or of the United States.

ARTICLE VIII AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles of Organization may be amended at any time by the members of this company owning the Class A Units.


