The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

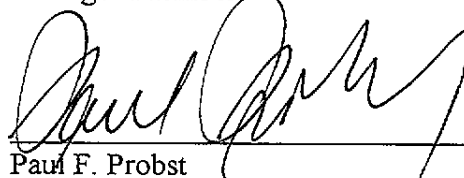
The manager may admit new members in its sole and unfettered discretion subject only to the condition that such additional member must agree in writing to be bound as a member of the Company.
