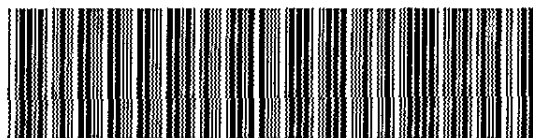

SECOND: Amendment adopted: —

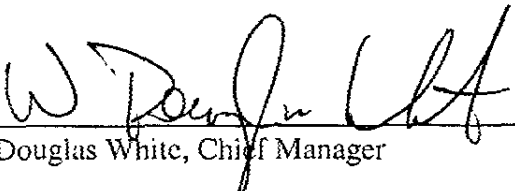
