Articles of Organization of D & C Industries, LLC (A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

- 1. NAME. The name of this limited liability company (the "Company") is D & C Industries, LLC.
 - 2. DURATION. The period of duration of the Company shall be perpetual.
