

OF 1118-1 TO ARTICLES OF ORGANIZATION OF

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of THEINSURANCEADVISOR FOR AGENTS, LLC, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, Florida Statutes § 608.411:
