FIRST: The name and state of incorporation of each of the constituent entities in the merger are as follows:

<u>Disappearing Entity</u>: Global Assets Advisors, Inc., a Florida corporation, charter ID P94000036765.

PLAN OF MERGER

The following plan of merger, which was adopted and approved by each party to the merger in accordance with 607.1103 and 608.4381, Florida Statutes is being submitted in accordance with Sections 607.1108 and 608.438, Florida Statutes.

FIRST: The name and jurisdiction of each merging party is Global Assets Advisors Inc., a Florida corporation, and Global Assets Advisors, LLC, a Florida limited liability company.

SECOND: The name and jurisdiction of the surviving party (the "Surviving Party") is Global Assets Advisors, LLC, a Florida limited liability company. Upon effectiveness of the merger, the name of the Surviving Party will continue to be Global Assets Advisors, LLC.

THIRD: The Articles of Organization of Global Assets Advisors, LLC in effect upon the effective date of the merger shall be the Articles of the Organization of the Surviving Party and shall continue in full force and effect until changed, altered, or amended as therein provided by the Florida Limited Liability Company Act.

FOURTH: The manner and basis of converting the interests of the merged party into the interests of the Surviving Party, are as follows: each share of Global Assets Advisors, Inc. shall be equal to a twenty percent (20%) interest in Global Assets Advisors, LLC.
