ARTICLE III. MANAGEMENT OF LIMITED LIABILITY COMPANY

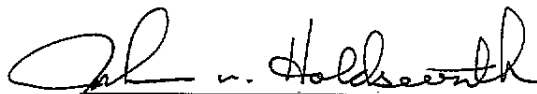
The limited liability company is to be managed by one or more managers and is therefore a managed company.

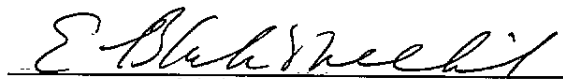

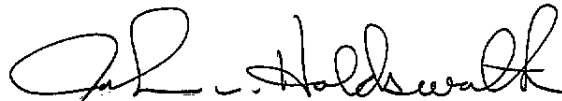
