

1. **NAME.** The name of the Limited Liability Company shall be Flotek Solutions, LLC, a Florida Limited Liability Company.


7. **EFFECTIVE DATE.** The Limited Liability Company's existence shall commence at the date and time when these Articles of Organization are filed.
