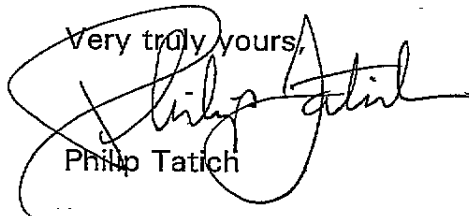

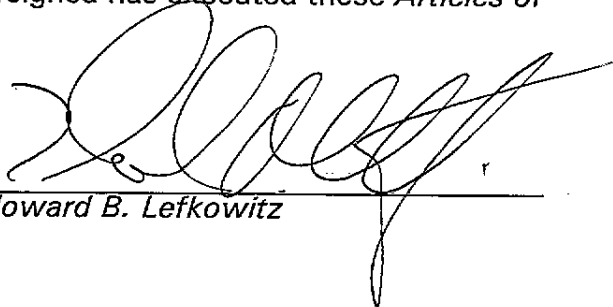
ARTICLE V

CONTINUATION OF BUSINESS

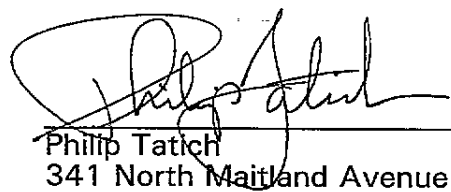
