ARTICLES OF ORGANIZATION OF BVG-SURFRIDER, L.L.C.

- 1. Name. The name of this limited liability company is BVG-SURFRIDER, L.L.C. (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The Company shall exist commencing effective as of July 23, 2001 and the Company's existence shall be perpetual.
- 3. <u>Purpose.</u> The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
