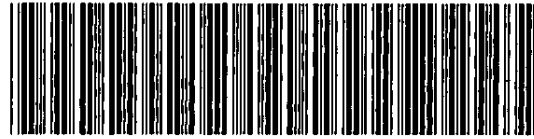

Bradley, III, Members of Raymar Aviation, Inc., a Florida Limited Liability Company, hereby consent to and approve of the following without a membership meeting in accordance with the Raymar Aviation, LLC Operating Agreement, effective as of this 15th day of May, 2007.

WHEREAS, Marta Alfonso, CPA, was appointed Receiver for Martin Bradley, Jr. and Martin Bradley, III ("Receiver"), by orders entered on April 3, 2006 and October 4, 2006 in *United States v. Martin J. Bradley, III et al.*, Case Number CR 405-59 in the United States District Court for the Southern District of Georgia;


NOW, THEREFORE, BE IT:
