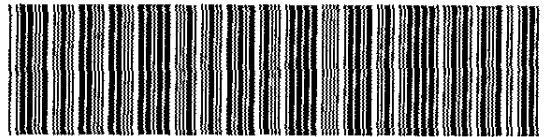

1. Name. The name of this limited liability company is BRENTWOOD HEALTH CARE ASSOCIATES, LLC, a Florida limited liability company (the "Company").
