ARTICLES OF ORGANIZATION

The Articles of Organization of Beauclerc Manor Health Care Associates, LLC (the "Company") were filed on July 30, 2001. In accordance with Section 608.411, these Amended and Restated Articles of Organization of Beauclerc Manor Health Care Associates, LLC have been duly executed and are being filed to amend and restate in their entirety all prior articles of organization filed on behalf of the Company. The Company's Amended and Restated Articles of Organization are as follows:

1. **Name.** The name of this limited liability company is BEAUCLERC MANOR HEALTH CARE ASSOCIATES, LLC, a Florida limited liability company.
2. **Duration.** The Company shall have perpetual existence, commencing on July 30, 2001, the date of filing the Articles of Organization with the Florida Department of State, unless the Articles of Organization or the operating agreement of the Company provide otherwise.
3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and business that may be conducted by a limited liability company under the laws of Florida.
4. **Principal Place of Business.** The Company's principal place of business is 9355 San Jose Boulevard, Jacksonville, FL 32217.
