## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF PLETCHER HEALTH CARE ASSOCIATES, LLC (Document # L01000012562)

The Articles of Organization of Fletcher Health Care Associates, LLC (the "Company") were filed on July 30, 2001. In accordance with Section 608.411, these Amended and Restated Articles of Organization of Fletcher Health Care Associates, LLC have been duly executed and are being filed to amend and restate in their entirety all prior articles of organization filed on behalf of the Company.
