

## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF HERITAGE HEALTH CARE ASSOCIATES, LLC

- 1. Name. The name of this limited liability company is HERITAGE HEALTH CARE ASSOCIATES, LLC, a Florida limited liability company (the "Company").
