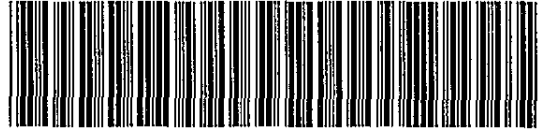

ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is WINTER GARDEN HEALTH CARE ASSOCIATES, LLC, a Florida limited liability company (the "Company").
