

ARTICLES OF ORGANIZATION
OF
OAK TERRACE HEALTH CARE ASSOCIATES, LLC**

1. Name. The name of this limited liability company is OAK TERRACE HEALTH CARE ASSOCIATES, LLC, a Florida limited liability company (the "Company").
