ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
US PET IMAGING, LLC

The Articles of Organization of US Pet Imaging, LLC were amended by the company's Board of Directors on September 25, 2002. The company is filing these articles of amendment to articles of organization pursuant to Section 608. 411 F.S.

1. Article II shall state: The mailing and street address of the Company's principal office is 2030 Bee Ridge Road, Suite A, Sarasota, Florida 34239.

2. Article V shall state: The Company shall be managed by its members.

3. Article VI shall state: The members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing member(s), and the existing member(s) shall determine the amount and nature of contributions by new members at the time the new members are admitted.

4. Article VII is added and shall state: The remaining members of the Company, if any, have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

5. The foregoing amendments to the articles of organization were duly adopted by the company's Board of Directors on September 25, 2002.

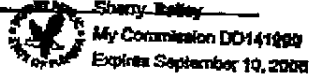

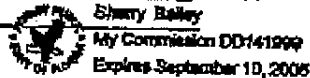
