ARTICLE I

The name of the limited liability company is SERTESA, LLC (hereinafter called the "Limited Liability Company").

ARTICLE II

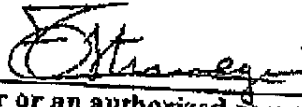
