**ARTICLES OF ORGANIZATION  
OF  
DIXIE TIMBER RESOURCES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, adopts the following Articles of Organization.

**ARTICLE I**

NAME

The name of the limited liability company is Dixie Timber Resources, L.L.C.

**ARTICLE II**

ADDRESS

The principal office and mailing address of the limited liability company shall be 2513 St. Michel Court, Ponte Vedra Beach, Florida 32082.

**ARTICLE III**

DURATION

The duration of the limited liability company shall be perpetual, and shall commence on the date these Articles are filed by the Department of State of Florida.

**ARTICLE IV**

MANAGEMENT

### MEMBERS' RIGHTS TO CONTINUE BUSINESS

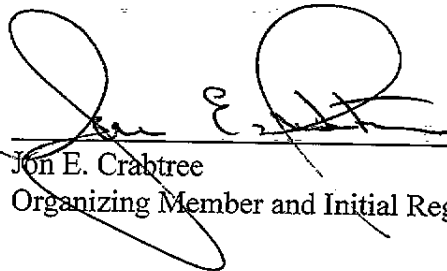

## ARTICLE VII

### INITIAL REGISTERED OFFICE AND AGENT
