Articles of Organization of JAMAZ LLC

THE UNDERSIGNED, being the authorized representative of all of the Members of Jamaz LLC, a Florida limited liability company formed hereunder, does hereby subscribe to, acknowledge and file the following Articles of Organization for the purpose of creating a limited liability company under the laws of the State of Florida.

FIRST: The name of this Company shall be:

Jamaz LLC

<u>SECOND</u>: The term of existence of this Company shall commence upon the filing of these Articles of Organization with the Florida Department of State, and this Company shall exist perpetually thereafter unless sooner dissolved according to these Articles of Organization or by law.

THIRD: This Company may engage in any activity or business permitted under the laws of the State of Florida.

FOURTH: The initial mailing address and principal place of business of this Company shall be 2875 N.E. 191 Street, Penthouse I, Aventura, Florida 33180 with the privilege of having its offices and branch offices at other places within or without the State of Florida.
