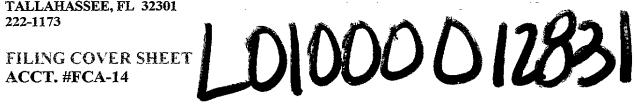

ARTICLES OF ORGANIZATION OF TALENTSPOT.COM, LLC

- 1. Name. The name of this limited liability company is **TALENTSPOT.COM**, **LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The existence of the Company shall be effective as of July 27, 2001, and shall thereafter be perpetual.
