

**ARTICLE IV. – MANAGEMENT**


Management of the Company is vested in the members in accordance with these Articles, or such operating agreement agreed to by the members of the Company, or the Florida Limited Liability Company Act.

**ARTICLE V. – EFFECTIVE DATE**


The effective date of its organization shall be the filing of the Articles of Organization.
