ARTICLES OF ORGANIZATION BAHAMAS RESORT, L.L.C.

The undersigned member, desiring to form a BAHAMAS RESORT, L.L.C., under and pursuant to Chapter 608, Florida Statues, entitled the Florida Limited Liability Company Act (the "Act"), does hereby adopt the following Articles of Organization for such Company:

- 1. Name. The name of this limited liability company is BAHAMAS RESORT, L.L.C. (the "Company")
- 2. Duration. This Limited company shall exist perpetually until dissolved in a manner provided by the law or as provided in the regulations adopted by the members.
- 3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida and that are permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
- 4. Registered Agent and Office. The name of the initial registered agent of the Company is Cecil D'Aguilar: the street address of the initial registered agent of the Company is 4337 W. Sunrise Boulevard, Plantation, Florida 33313.
- 5. Principal Office: Mailing Address and Street Address. The street address and mailing address of the Company's principal office is 4337 W. Sunrise Boulevard, Plantation, Florida 33313.
- 7. Management of the Company. The business of the Company shall be managed by its members in proportion to their initial contribution to the capital of the Company expressed as a percentage of the total initial capital of the Company. These percentages shall not vary as function of changes in their capital account balances.
- 8. Operating Agreement; Member's Agreement. At the time of executing these of Articles of Organization, the members of the Company shall adopt an Operating Agreement containing all provisions for the regulation and management of this recompany not inconsistent with the law or these articles. The power to alter, amend on repeal the Operating Agreement shall be vested in the member or members of this Company (as the case may be; if more than one member, by vote of the members representing a majority of the membership interests of the Company). The members of of the Company, if more than one, also may adopt a member's agreement containing mutually accepted guidelines regarding the administration and governance of the Company and provisions governing the transfer of membership interests.
- 9. Date of Existence of the Company. The existence of the Company shall commence on the date of filing of the Articles of Organization with the Florida Department of

10. Transfer of Interest. No member shall have the right to transfer any interest in the Company unless authorized by vote of all the remaining members or otherwise as may be provided in any Members' Agreement.
