The undersigned, being authorized to execute and file these Articles, hereby certifies that:

**ARTICLE I - Name:**

The name of the limited liability company is Nugent/Steigleman, LLC (the " Limited Liability Company").

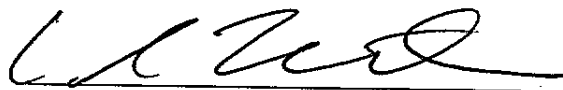
