ARTICLES OF AMENDMENT OF THE ARTICLES OF ORGANIZATION OF TOOMY RESTAURANTS, LLC

TOOMY RESTAURANTS, LLC, a limited liability corporation organized and existing under the laws of State of Florida (the "LLC"), in order to amend its Articles of Organization, in accordance with the requirements of Chapter 608, Florida Statutes, does hereby certify as follows:

- 1. The name of the LLC is TOOMY RESTAURANTS, LLC.
- 2. The date of filing of the Articles of Organization of the LLC is August 3, 2001.
- 3. Article I of the Articles of Organization is hereby amended to change to LLC's name "TOOMY RESTAURANTS, LLC" to "GOLD COAST GRILL 1, LLC."
- 4. These Articles of Amendment of the Articles of Organization shall be effective immediately upon filing by the Secretary of State of the State of Florida, all required taxes and fees having been paid, and thereafter, the name of the LLC shall be "GOLD COAST GRILL 1, LLC" and Article I of the Articles of Organization of the LLC shall read as follows:

"ARTICLE I - NAME

The name of the Limited Liability Company is: GOLD COAST GRILL - 1, LLC."
