## ARTICLES OF ORGANIZATION OF TEAM 19 RACING, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

## ARTICLE I - NAME

The name of the Limited Liability Company is Team 19 Racing, L.L.C. (the "Company")

#### ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is: 100 S. Orange Avenue, Suite 410, Orlando, Florida 32801.

#### ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than December 31, 2051, unless the Company is earlier dissolved as provided in these Articles of Organization.

### ARTICLE IV - REGISTERED AGENT AND REGISTERED OFFICE

The name and street address of the registered agent and registered office of the Company in the State of Florida is: Akerman, Senterfitt & Eidson, P.A., Phillips Point East Tower, 777 South Flagler Drive, Suite 900, West Palm Beach, Florida 33401, Attention: James R. Kay, Esquire, Shareholder.

## ARTICLE V - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all of the members of the Company and upon such terms and conditions as shall be determined by all of the members. A member may transfer his or her interest in the Company only as ser forth in the Operating Agreement of the Company.

## ARTICLE VI - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all of the remaining members, provided there is at least one remaining member.

### ARTICLE VII - MANAGEMENT

The Company shall be managed by a manager or managers in accordance with the Operating Agreement adopted by the member(s) for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
