OF
PODIUM, LLC

ARTICLE I — Name:

The name of the Limited Liability Company (hereinafter referred to as the "Company") is
"PODIUM, LLC"

ARTICLE II — Duration:

The Limited Liability Company's period of duration shall be perpetual.

ARTICLE III — Address:

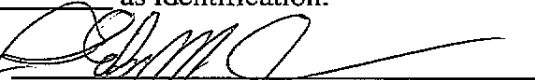
