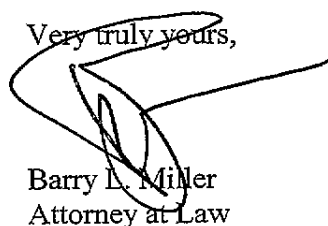

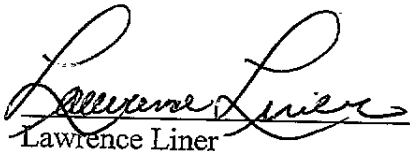

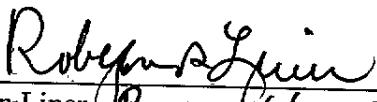
1. **Name.** The name of the limited liability company is Palmer Street Properties, L.L.C..
