**ARTICLES OF ORGANIZATION
OF
RICHLAND TOWERS -FAYETTEVILLE, LLC**

1. Name. The name of this limited liability company is **RICHLAND TOWERS - FAYETTEVILLE, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The existence of the Company shall be effective as of August 3, 2001, and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
