## ARTICLE VI. – ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members, and the terms and conditions of such admissions, shall be made by unanimous agreement of all members.

## ARTICLE VII. – MEMBERS' RIGHT TO CONTINUE BUSINESS

The right of the remaining members of CANDY CAFÉ & PASTRY, L.L.C., to continue the business on the death, retirement, resignation, expulsion, or dissolution of a member, or the occurrence of any other event, which terminates the continued membership of a member in the limited liability company, shall be as follows:

The members of CANDY CAFÉ & PASTRY, L.L.C., agree that the company shall not automatically dissolved upon the death, retirement, resignation, expulsion, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company. In the alternative, the remaining members shall vote to determine whether to continue the business when a member leaves. The business of the limited liability company shall continue as before if the consent of all the remaining members is given as provided below, thereby dispensing with the need to dissolve and wind-up the business.


CANDY CAFÉ & PASTRY, L.L.C., shall continue, despite the dissociation of any member-manager or member, if consent is given by:

- (1) The remaining members holding a majority of the sharing ratios of all the remaining members. This determination shall be based on a reasonable estimates of profits from the date of the dissociation to the projected termination of the limited liability company, taking into account present and future allocations of profits under the regulations that are in effect as of the date of the dissolution event; and
- (2) The remaining members holding a majority of the capital accounts of all of the remaining members. This determination shall be made as of the date of the dissociation.

The rights of the members expressed herein are intended to conform with Section 608.441(1) (c), Florida Statutes.


