ARTICLES OF ORGANIZATION

OF

THE UNDERSIGNED, RODNEY J. TROYER, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

ARTICLE VII - ADMISSION OF NEW MEMBERS

ARTICLE VIII - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion or bankruptcy of a member or manager, or upon the occurrence of any other event that terminates the continued existence of the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there must be at all times at least two (2) remaining members.

ARTICLE IX - MANAGEMENT

The Company shall be managed by the members in accordance with Regulations adopted by the members from time to time for the management of the business and affairs of the Company. These Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with Florida law or these Articles of Organization.
