**ARTICLES OF ORGANIZATION  
OF  
CONTINENTAL HOIST AND MAST CLIMBER SALES, LLC**

1. Name. The name of this limited liability company is CONTINENTAL HOIST AND MAST CLIMBER SALES, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles of Organization with the Florida Department of State, unless these Articles of Organization or the operating agreement of the Company provide otherwise.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and business that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The mailing and street address of the Company's principal office is 4301 North 40<sup>th</sup> Street, Tampa, FL 33610.
5. Registered Agent and Office. The name of the initial registered agent of the Company is John H. Rains, III. The street address of the initial registered agent of the Company is 501 E. Kennedy Blvd., Suite 750, Tampa, FL 33602.
6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all the Members of the Company at the time the admission is sought.
7. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the company, the Company shall be dissolved unless all remaining members agree in writing to continue the business.
8. Management of the Company. The management of the Company is reserved to the members. The Company shall initially be managed by its sole member John A. Pullaro, who is located at 4301 North 40<sup>th</sup> Street, Tampa, FL 33610.
9. Authorized Representative. The sole member has authorized John H. Rains, III to act in the capacity of Authorized Representative for the Company.


