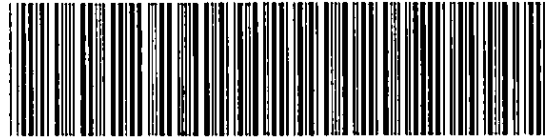

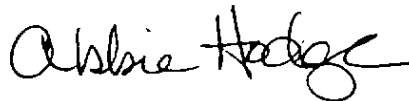

ARTICLE IV – Registered Office and Agent

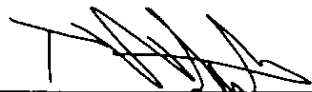
