### ARTICLES OF ORGANIZATION

OF

#### GRABIT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the Limited Liability Company shall be GRABIT. LLC (the "Company").
