ARTICLES OF ORGANIZATION

OF

The undersigned organizer to these Articles of Organization, a natural person competent to contract, hereby forms a Limited Liability Company for profit under the laws of the State of Florida.

ARTICLE I - NAME OF COMPANY

The members of this Company shall have the sole power to establish, enact, alter or repeal regulations for the management of this Company.

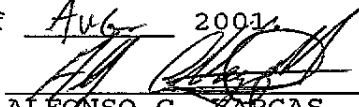
ARTICLE IX -AMENDMENTS

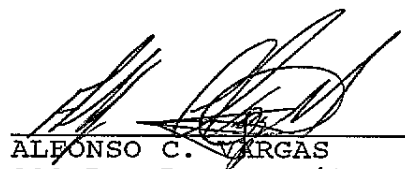

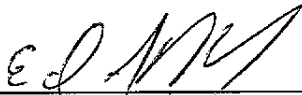
