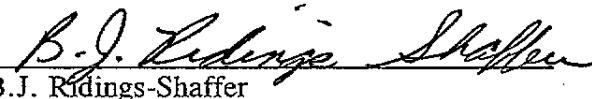
ARTICLE VII - Members Rights to Continue Business:
