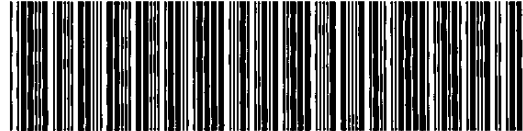

**AMENDMENT TO ARTICLES OF ORGANIZATION OF  
FLOYD STREET PROPERTIES, LLC, a Florida limited liability company**


**THE UNDERSIGNED, constituting the sole Managers/Members of Floyd Street Properties, LLC, a Florida limited liability company ("Floyd Street"), hereby amend the Articles of Organization of Floyd Street Properties, LLC, executed by Herbert Silverstein, M.D., and filed on August 14, 2001 ("Articles of Floyd Street"), by incorporating the following provisions into the Articles of Floyd Street, and further that this amendment controls over any contrary provision in the above-referenced Articles of Floyd Street:**


**ARTICLE II, 1. of the Articles of Floyd Street is amended to strike the paragraph and replace it with:**

1. "to engage solely in the acquisition, ownership, operation and maintenance of the real estate project known as 1901 Floyd Street, 34239, located in Sarasota, County, Florida (the "Property") and activities incidental thereto.

This Amendment will also clarify that Herbert Silverstein and Seth Rosenberg are the sole Members of Floyd Street.
