# ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a limited liability Company under Florida Statutes 608.401 and 608.514, the Florida Limited Liability Company Act (the "Act"), does sign, verify and deliver to the Secretary of State of the State of Florida these Articles of Organization.

#### ARTICLE I - Name

The name of the Limited Liability Company (which is hereinafter referred to as the "Company") shall be: SUN CITY CENTER FUNERAL HOME, LLC

#### ARTICLE II - Purpose

The general nature of the business to be transacted by the Company, and the purposes and powers of the Company, shall be as follows:

- (a) To engage in the business of operating a funeral home.

  (b) Sue or be sued, or complain or defend, in its name.
- (c) Purchase, take, receive, lease, subscribe for, or otherwise acquire, own, hold, improve, vote, use, or otherwise deal in or with real or personal property, or an interest in real or personal property or any legal or equitable property, wherever located.
- (d) Sell, convey, mortgage, pledge, create a security interest in, lease, exchange, lend, or otherwise dispose of, all or any part of its property or assets.
- (e) Make contracts or guarantees, or incur liabilities; borrow money; issue its notes, bonds, or other obligations; secure any of its obligations by mortgage or pledge of all or any part of its property, franchises, and income; or make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting company; a corporation which owns, directly or indirectly, a majority of the outstanding stock of the contracting company; or a corporation which owns, directly or indirectly, the majority of the outstanding stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding stock of the contracting company, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting company; or make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting company.
- (f) Lend money, invest or reinvest its funds, or receive and hold real or personal property as security for repayment.

- (g) Conduct its business, locate offices, and exercise the powers granted by the Act within or without this state.
- (h) Elect or appoint managers and agents of the limited liability company, define their duties, fix their compensation, and lend them money and credit.
- (i) Make and amend its regulations, not inconsistent with its articles of organization or with the laws of this state, for the administration and regulation of the affairs of the Company.
- (j) Make donations to the public welfare or for charitable, scientific, or educational purposes.
- (k) Indemnify a member or manager or any other person as provided in the Act against expenses actually and reasonably incurred by him or her or it in connection with the defense of an action, suit, or proceeding, whether civil or criminal, in which he or she or it is made a party.
  - (I) Cease its activities and surrender its certificate of organization.
- (m) Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the Company is organized.
  - (n) Transact any lawful business that will aid governmental policy.
- (0) Pay pensions and establish pension plans, pension trusts, profit-sharing plans, and other incentive plans for any or all of its managers and employees.
- (p) Be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other entity.
- (q) Make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the Company.

#### ARTICLE III - Address

#### **ARTICLE IV - Duration**

The existence of the Company shall commence upon the filing of these articles of

With the unanimous written consent of the remaining member or members, the remaining member or members of the Company, if any, shall be entitled to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company.
