**ARTICLES OF ORGANIZATION OF  
JCC ENTERPRISES, LLC  
LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I - Name**

The name of the limited liability company (hereinafter referred to as the "Company") is "JCC ENTERPRISES, LLC."

**ARTICLE II - Address**

The mailing address and street address of the principal office of the Company is 18 South Magnolia Avenue, Ocala, Florida 34478.

**ARTICLE III - Duration**

The period of duration for the Company shall be perpetual.

**ARTICLE IV - DESIGNATION OF REGISTERED AGENT
